WHEREAS, the American Rescue Plan Act (the "ARPA") was enacted, among other purposes, to provide additional relief to address the continued impact of the COVID-19 Disease and Public Health Emergency; and

WHEREAS, Section 9901 of ARPA amended Title VI of the Social Security Act to add sections 602 and 603, which established the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund; and

WHEREAS, the United States Department of the Treasury combined the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund to create the State and Local Fiscal Recovery Fund Program ("SLFRF"); and

WHEREAS, the County of Monmouth received an amount from the SLFRF (the "Relief Funds"), among other purposes, to support urgent COVID-19 response efforts and address systemic public health and economic challenges; and

WHEREAS, as the recipient of Relief Funds, it is the responsibility of the County of Monmouth to disburse the Relief Funds to eligible recipients in accordance with the terms and provisions of the SLFRF and any guidelines or regulations issued by the United States government or any of its agencies and/or departments; and

WHEREAS, the Board of County Commissioners of the County of Monmouth passed a resolution 2022-0201 on March 8, 2022

outlining priorities for the Relief Funds that included, among other priorities, assistance to not-for-profit organizations; and

WHEREAS, the County of Monmouth developed a COVID-19 Community Recovery Grant Program for Not-for-Profit Organizations and issued a Notice of Funding Opportunity that was publicly available on the County's website; and

WHEREAS, the purpose of the COVID-19 Community Recovery Grant Program for Not-for-Profit Organizations is to provide financial support to organizations who: (i) serve veterans and their families through supportive housing, education, healthcare and community reintegration; (ii) combat food insecurity; (iii) provide temporary care, housing and adoption services for animals; (iv) support special needs persons in their transition into the community from institutional care; (v) provide for the presence and preservation of the arts, historic and cultural resources; and (vi) provide mental health services; and

WHEREAS, the Notice of Funding Opportunity established a discretionary grant process to select recipients from among all eligible recipients, to decide to make or not make an award based on the programmatic, technical, or financial content of an application, and to decide the amount of funding to be provided to carry out program activities; and

WHEREAS, the County of Monmouth reviewed each responsive grant application consistent with the terms of the Notice of Funding Opportunity.

NOW, THEREFORE, BE IT RESOLVED that the County of Monmouth shall award grant funds to the below listed not-for-profit organizations under the COVID-19 Community Recovery Grant Program:
