## FURNISHING AND DELIVERY OF CHARTER BUS TRANSPORTATION (56 PASSENGER BUSES) FOR THE PERIOD OF JANUARY 1, 2026, TO DECEMBER 31, 2026.

FOR THE MONMOUTH COUNTY PARK SYSTEM, LINCROFT, NEW JERSEY  
TO THE MONMOUTH COUNTY BOARD OF RECREATION COMMISSIONERS.

### 56 Passenger Busses

#### 1. One-Day Trips

a. Base rate (includes 10 hours + 100 miles) \$ 1895.00

b. Cost per mile, over 100 miles \$ 6.00

c. Cost per hour, after 10 hours \$ 100.00

(10 initial hours include 9 hours Charter + 1 hour Dead-head)

d. Cancellation Fee (Less than five (5) days' notice) \$ 500, full amount for cancellation day of travel

e. The above rates are to be applied to give a price on the following hypothetical trips.

(1.) 9-hour charter and 105 miles \$ 1925.00

(2.) 11-hour charter and 155 miles \$ 2325.00

(3.) 12-hour charter and 240 miles \$ 2935.00

f. Total of e. (1), e. (2) and e. (3) \$ 7185.00

#### 2. Multi-Day Trips

a. Base Rate (includes 200 mile per day average) \$ 1750.00

b. Cost per mile, over 200 miles per day average \$ 4.25

c. Cancellation fee (less than 5 days' notice) \$ 500, full amount for cancellation day of travel

d. The above rates are to be applied to give a price for the following hypothetical trips.

(1.) 6 days, 5 nights and 2015 miles + second driver. \$ 13,963.75

(2.) 3 days, 2 nights and 625 miles \$ 5356.25

(3.) 2 days, 1 night and 425 miles \$ 3606.25

e. Total of d. (1), d. (2) and d. (3) \$ 22,926.25


