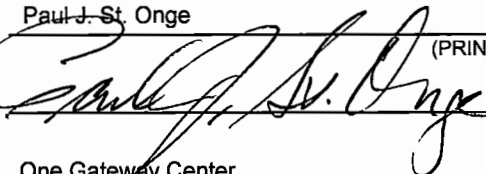

- Coordinate and advocate County projects to the appropriate state and federal regulatory agencies for project regulatory approvals in Trenton and Washington, DC.

F. TERMS OF ENGAGEMENT/SPECIFIC PROPOSAL BASED ON PROJECT RFP

The services provided by Gibbons shall be for a twelve-month (12-month) period of time, commencing on approval and ratification of an agreement between Gibbons and the County of Monmouth. Either the County of Monmouth or Gibbons may terminate the engagement at any time for any reason by written notice, subject on our part to the applicable Rules of Professional Conduct.

In the event that we terminate the engagement, we will take such steps as are reasonably practicable to protect the County of Monmouth's interests on matters for which we are retained, and, if you so request, we will suggest to you a possible successor transportation consultant and provide that individual with whatever papers and property you have provided to us.

Per the terms outlined in the County's RFP, Gibbons agrees not to publish or otherwise publicize any information relating to the project/engagement without written permission from the County. Gibbons will refer all inquiries from news organizations to the County and will release no information unless specifically directed by the County.

G. SCHEDULE OF FEES/EXPENSES FOR PROPOSED SERVICES

For the foregoing transportation consulting services, the firm will charge a flat monthly fee of \$10,000 per month, plus reasonable expenses not to exceed \$10,000 per year.

This flat monthly fee schedule enables the County of Monmouth to budget for our services and does not limit the attention Gibbons will devote to the County's transportation-related matters.
