WHEREAS, the Authority is required by N.J.S.A. 40A:5-15 to undertake an annual audit and certain related activities which require the services of an independent Registered Municipal Accountant; and

WHEREAS, the Authority may need to undertake a number of certain related accounting services or studies in order to maintain a policy of good fiscal management, and

WHEREAS, the Auditor has offered to provide such services,

**BE IT HEREBY AGREED** by the parties as follows:

A. <u>Term of Contract</u> – This contract shall be for the fiscal year ending July 31, 2022.

## B. Scope of Services

- 1. The parties agree that the following services shall be performed by the Auditor to assist the Monmouth County Improvement Authority in fulfilling mandatory requirements of statute.
  - a. Preparation of July 31, 2022 audit.
  - b. Personal presentation of the 2022 audit to the Monmouth County Improvement Authority, with discussions of 2022 financial transactions, if required.

#### C. Payment for Services

- 1. Payment for all services shall be by itemized voucher.
- 2. Payment for the annual audit not to exceed \$15,000.00
- 3. Payment for any project in addition to the annual audit shall be made on vouchers submitted showing time spent by the Auditor and/or his staff. Hours worked shall be billed in accordance with the schedule appended hereto as Appendix I.

## D. Representations by the Parties

- 1. The Auditor represents that he has available sufficient skilled personnel at all times to provide the services specified herein in a timely manner and in full compliance with good accounting practice and with the laws and regulations of the State of New Jersey. The Auditor represents that in scheduling work, he will make every effort to schedule his activities and his work with the Authority employees and in the Authority offices in accordance with the work schedule needs of those employees and offices.
- 2. The Authority represents that it will provide such data as the Auditor requires in a timely manner.
