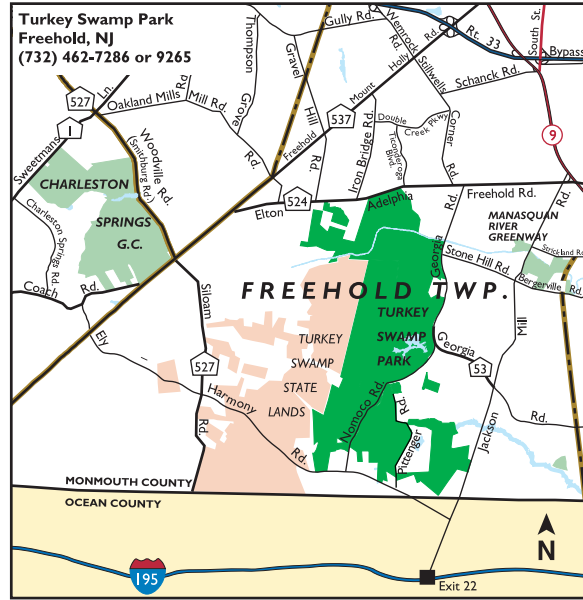


## Information About Lyme Disease

To avoid contact with the deer tick that may carry Lyme Disease, stay away from tall grass and shrubby areas, wear light-colored clothes, tuck long pants into socks, and check yourself for ticks during and after each visit to the park.



**From NJ Turnpike, Exit 7A:** Take I-195 east to Exit 22. Turn left onto Jackson Mills Rd., north. Follow to Georgia Rd. and turn left. Follow Georgia Rd. for 1.7 miles to main park entrance on left.

**From Garden State Parkway, Exit 98:** Take I-195 west to Exit 22. Turn right onto Jackson Mills Rd., north. Follow to Georgia Rd. and turn left. Follow Georgia Rd. for 1.7 miles to main park entrance on left.

**From State Hwy. 9 South:** In Freehold, turn right onto Route 524 west (Elton-Adelphia Rd.). Follow for 1.2 miles to Georgia Rd. and turn left. Follow Georgia Rd. for 1.7 miles to main park entrance on right.

## Welcome to Turkey Swamp Park Campgrounds

The 64 pull-through campsites at Turkey Swamp Park can accommodate both tent campers and travel trailers: 52 can be reserved, while the other 12 are available on a first-come/first-served basis. All campsites have water and electrical hook-ups, and can accommodate a maximum of 6 people. There is a free dump station available to registered campers, and the restroom has hot showers and laundry facilities.

The park itself offers 4 playgrounds (one inside the campground), a 17-acre lake for boating and fishing (boats available for rental), 8 miles of trails, open playfields, vending machines, and a variety of large-group facilities for rental.



### Reservations

Advance reservations are available for stays of at least 2 nights, and all nights must be pre-paid in full. Reservations may be secured by:

- Phone with a VISA/MasterCard (call 732-462-7286)
- Mail with a personal check/money order. Please fill out and send the enclosed Reservation Request Form.
- In-person with cash, VISA/MasterCard, or personal check

When making reservations for a group, the full name and address of each family is required.

### Camping Season

The campground is open from April 1 – November 15, the park itself is open year round. Reservations will be accepted after January 1st for that year.

## Family Campground

- 64 wooded campsites
- Electrical service (20 amp/30 amp)
- Water service
- Dumping Station
- Modern restrooms with hot showers and laundry
- Fire rings for charcoal cooking and campfires
- Picnic tables
- Playground

## Forest View Cabins

- Two wood cabins (one is handicapped accessible)
- Sleeps six (1 double bed, 2 bunks)
- Light/electrical outlets
- Picnic area with fire pit
- Water spigot outside each cabin



## Group Camping

Platform tent camping and tent campsites for organized groups are available at the park's Nomoco Activity Area (located on Nomoco Rd, one mile southwest of the main entrance). Please call (732) 462-7286 or visit us online for more information.

## PROTECT YOUR PARKS

The Park System preserves and manages natural and cultural resources on more than 14,500 acres of land in Monmouth County. Protecting water quality, eliminating invasive plant species, and promoting healthy wildlife habitats are just a few objectives. Please help protect the park by leaving flowers, plants, animals, and other features as you found them; adhering to posted park rules; using designated containers for trash, recyclables and pet waste; and keeping your pets leashed. Alcoholic beverages are not permitted.

An overabundance of white-tailed deer in and around this park is threatening the health of native plant and animal species. Portions of Turkey Swamp Park may be open for deer hunting during all or some of the State-regulated hunting season. All hunting areas are clearly posted. 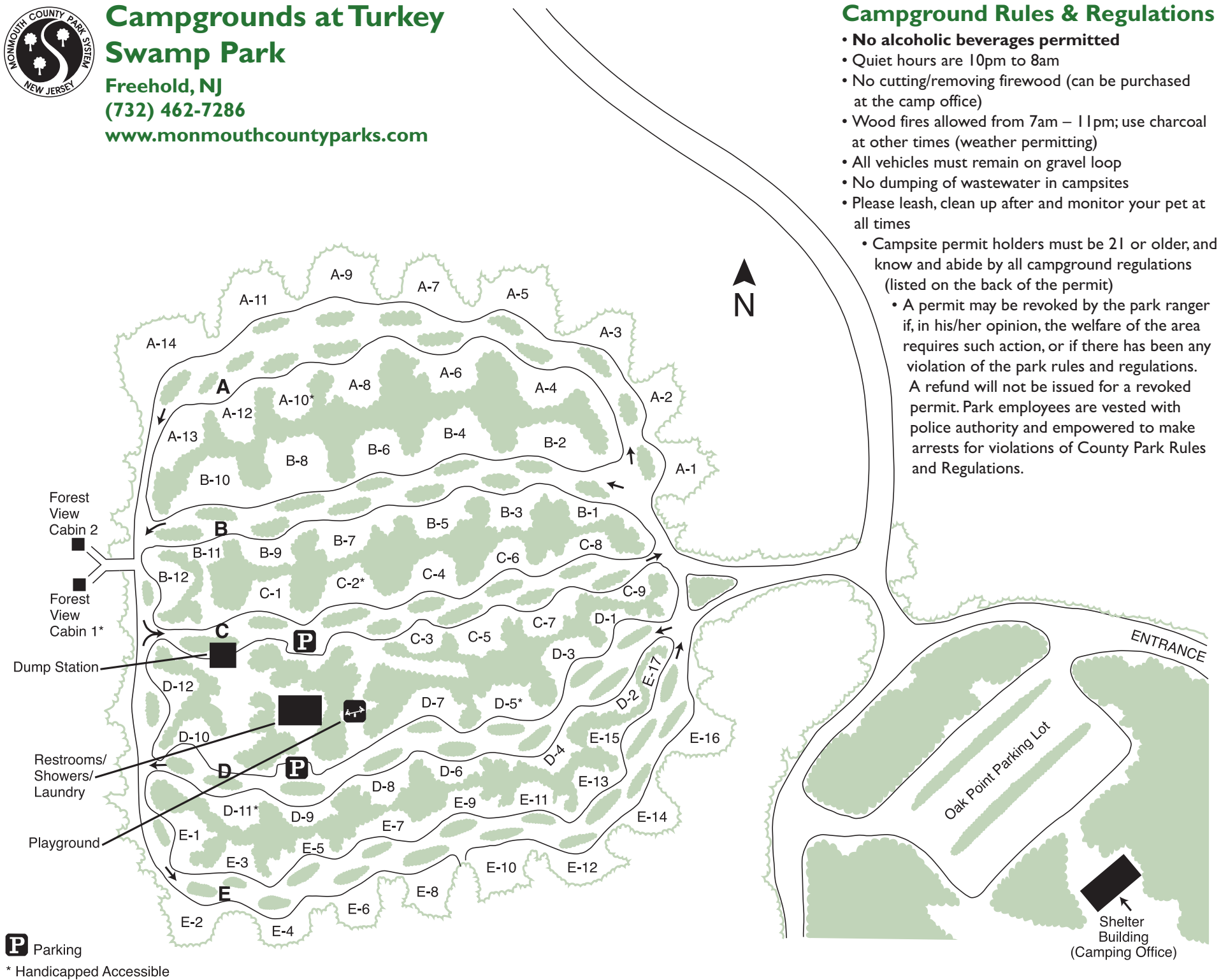

**Campground Rules & Regulations**

- No alcoholic beverages permitted
- Quiet hours are 10pm to 8am
- No cutting/removing firewood (can be purchased at the camp office)
- Wood fires allowed from 7am – 11pm; use charcoal at other times (weather permitting)
- All vehicles must remain on gravel loop
- No dumping of wastewater in campsites
- Please leash, clean up after and monitor your pet at all times
- Campsite permit holders must be 21 or older, and know and abide by all campground regulations (listed on the back of the permit)
- A permit may be revoked by the park ranger if, in his/her opinion, the welfare of the area requires such action, or if there has been any violation of the park rules and regulations. A refund will not be issued for a revoked permit. Park employees are vested with police authority and empowered to make arrests for violations of County Park Rules and Regulations.
