**PLEASE READ THE FOLLOWING CAREFULLY:**

### **QUALIFICATIONS:**

- The show is open to all artists and craftspersons, professional or amateur, displaying original work. **No commercially purchased merchandise, kit work, artwork copies, numbered paintings, flea market items, or alcohol/CBD infused products.** To enforce this policy and to ensure a quality show, we will require three (3) photographs of your work to accompany each application.
- Vendors from the 2024 Craft Shows or the 2025 Spring Craft Show at Fort Monmouth only need to re-submit photos and NJ Sales Tax certificate if selling in a different craft category than from the previous shows.
- The Monmouth County Park System reserves the right to deny entry to any exhibitor whose work is determined to be unacceptable or remove any exhibitor not displaying their own originally crafted work.

### **SPACE ALLOCATION:**

- Spaces will be in the Rec Center and will be assigned in advance. Each space is 8' x 8'.
- SPACES WILL BE ASSIGNED IN THE ORDER THAT COMPLETED APPLICATIONS AND PAYMENT ARE RECEIVED AT FORT MONMOUTH. Vendors selling similar items will be spaced out so they are not in adjacent spaces.
- Spaces limited to one (1) per vendor.
- Crafters must supply their own tables and chairs.
- Crafters must account for the total dimension of their display. No extension into adjacent space will be permitted.
- The Monmouth County Park System reserves the right to limit the number of crafts displayed by those of a particular type of work in order to achieve a well-balanced and evenly represented show.

### **APPLICATION PROCEDURE:**

All applications must be returned with the appropriate fee by mail or in person by November 1, 2025.

1. Application must be completed, signed and dated.
2. Applicants **must** provide a legible copy of the business'/organization's State of New Jersey Sales Tax Certificate of Authority.
3. Three (3) photographs of your work must accompany application. If you wish to have your photographs returned, you must also send a self-addressed, stamped envelope.
4. If you choose to pay by check please make check payable to **"Board of Recreation Commissioners"**. Your check must be included with your application.
5. Submitting Craft Show Applications:
  - a. **In person:** Applications can be submitted in person at Fort Monmouth Recreation Center Monday-Friday from 10 a.m.–5p.m.
  - b. **By mail:** Applications must be mailed to: Fall Craft Show, Monmouth County Park System, 805 Newman Springs Road, Lincroft, NJ 07738, Attn: Jim Butler. Please do not attempt to mail anything directly to the Fort Monmouth Recreation Center address.
6. Space is limited to the first 50 craft vendors that submit their complete application, payment, photos, and NJ Sales Tax Certificate. Emailed applications cannot be accepted and any applications that arrive after the Fall Craft Show is filled will be placed on a wait list. Every vendor that is accepted in the show will be notified by email.

### **SET-UP AND TAKE DOWN:**

- Vendors can set up their space on Friday, November 7: **12–7 p.m.**
- Vendors will still be able to set up Saturday morning from 7:30–8:30 a.m.
- Removal time for displays will be Saturday from 2–3:30 p.m.

### **PARKING:**

Parking will be available in an area adjacent to the sales area. Vendors will be allowed to drive up to the Recreation Center to unload. There will be no vendor parking available in the main parking lot.

### **CANCELLATION:**

The Monmouth County Park System reserves the right to cancel a scheduled display date in case of severe inclement weather. In that event, a full refund will be given; however, our events usually take place rain or shine.
