#### **PROGRAM OVERVIEW**

RecAssist is a financial assistance program designed to help provide access to Monmouth County Park System programs and activities for county residents that qualify for a fee discount based on income restrictions.

A wide range of Park System programs and camps are offered to participants at a discount of 25%. Additional subsidies may be available through Friends of the Parks. A limited number of programs are ineligible for discount.

Adult participants are provided with a RecPass ID, enabling individuals and families FREE access to the following activities:

- Seven Presidents Oceanfront Park
- · Cross-country ski and snowshoe rentals
- Open Shoot Archery
- Boat rentals at Thompson Park, Turkey Swamp Park, and Manasquan Reservoir
- Monmouth County Fair

#### **ELIGIBILITY GUIDELINES**

Funds are limited, and therefore guidelines have been established to determine household eligibility.

Applicants must be residents of Monmouth County. Proof of residency is required, for example, a copy of a lease or utility bill.

Residents participating in one or more of the below government assistance programs would be deemed eligible for RecAssist:

- NJ Family Care/Medicaid
- Supplemental Nutrition Assistance Program (SNAP)
- Supplemental Security Income (SSI)
- NJ Supplemental Nutrition Program for Women, Infants and Children (WIC)

Proof of participation in one or more of the above programs must be provided when application is submitted. Please send copies and do not send originals.

RecAssist eligibility is valid for one (1) calendar year and must be renewed annually.

### **QUICK FACTS**

Applications will be reviewed confidentially by Park System staff. Supporting documents will be destroyed and not stored once the application process is complete.

Programs and summer camps led by non-Park System agencies and third-party vendors are not currently eligible for discounts.

To receive your discount, registration must be done in-person or by telephone.

RecAssist can be used for all members in a household that are listed on the application.

Applicants will receive an update by e-mail when the approval process is completed. RecAssist permit numbers will be provided and are required for participant to receive applicable discounts. Please expect up to two (2) weeks for processing.
