WHEREAS, the County Program requires the entering into a Cooperative Project Agreement memorializing the terms and conditions of the County's participation in a municipal acquisition project; and

WHEREAS, the Township of Holmdel ("Holmdel") and the County are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey law to enter into a Cooperative Project Agreement; and

WHEREAS, the County, through its dedicated Open Space Trust Fund has the ability and desires to incentivize the funding of municipal land acquisition for the purposes of open space preservation; and

WHEREAS, the County and Holmdel have negotiated a Cooperative Project Agreement, in a form substantially similar to that which is annexed hereto as EXHIBIT A, and the terms of which are incorporated into this resolution as if set forth at length herein; and

WHEREAS, the Crawford Hill Horn Antenna Site, located in Holmdel, is the highest point in Monmouth County and houses the Horn Antenna; and

WHEREAS, the Crawford Hill Horn Antenna Site, is the location where former Bell Labs physicists Arno Penzias and Robert Wilson utilized the Horn Antenna to detect the cosmic microwave background radiation that provided evidence of the Big Bang, which earned the pair the od scientists the 1978 Nobel Prize in Physics for this work; and

WHEREAS, the Crawford Hill Horn Antenna Site, was designated a National Historic Landmark in the National Register of Historic Places in 1989 and was listed on the New Jersey Register of Historic Places on February 24, 1993.

WHEREAS, the Crawford Hill Horn Antenna Site will add ± 35 acres of Holmdel Township Open Space, allowing for the historic preservation of this unique site for the benefit of all County residents; and

WHEREAS, Holmdel has adopted Resolution #2023-312 indicating its request to enter into a Cooperative Project Agreement with the County to affect the preservation of the Crawford Hill Antenna Site; and
