The Monmouth County Park System (MCPS) and the New Jersey Department of Transportation (NJDOT) are committed to developing trail improvements that best balance pedestrian needs, the environment, community concerns and costs. We will hold a Public Information Center (PIC) to provide residents with information about the Henry Hudson Trail Extension Project. You are encouraged to participate and provide comments.

**The Meeting:**

The PIC will be an “open house” running from 4:00 to 7:00 PM on Tuesday August 29, 2023. At the meeting you will have the opportunity to review displays, ask questions and submit comments. Property owners with rental units are advised that tenants are also invited and encouraged to participate.

**Henry Hudson Trail Safety Extension:**

The MCPS maintains the Henry Hudson Trail (HHT), which is Monmouth County’s longest and most heavily traveled multi-use regional trail. MCPS is designing the Henry Hudson Trail Section 2 trail extension in Marlboro Township. This extension will run along the Freehold & Atlantic Highlands Railroad right-of-way beginning north of the First Dutch Reformed Church and extending about three-quarters of a mile before turning east to meet the existing trail at the North Main Street (NJ Route 79) and Wyncrest Road intersection. At the southern end, the alignment will meet a separate MCPS project which will construct a new trail overpass across Newman Springs Road (CR 520) tying to the trail system in Big Brook Park. The new trail will be constructed in compliance with the Americans with Disabilities Act (ADA).

**Project Schedule:**

Preliminary Engineering 2023  
Final Design 2024  
Construction 2025

**Construction Cost:**

Construction costs are estimated at \$600,000 which is expected to be reimbursed through the Federal Transportation Alternatives Program (TAP), administered through NJDOT Local Aid.
