# **GOLF REPORT**

Superintendent of County Parks for Golf, Michael Janoski, provided an update to the Board on the performance of the County Golf Courses for 2022. He reported that total rounds played at the County's six facilities was 308,950, which included 11,184 rounds by junior golfers. Total golf course gross revenue for the year was \$16,397,908, up from \$15,989,857 in 2021.

Mr. Janoski also provided an update to the Board on recent discussions with representatives of First Tee of the Jersey Shore on a possible partnership to build and operate an instructional three-hole facility at Wolf Hill Recreation Area in Oceanport.

Vice Chairman Anthony Fiore asked Mr. Janoski to review the possibility of passing along credit card processing fees to golfers.

Commissioner Tom Adcock asked for additional information on the age breakdowns across the board for rounds played.

Mr. Janoski said that demographic information is not collected for out-of-county golfers.
