GOLF REPORT:

Superintendent of County Parks for Golf Mike Janoski provided the Board an overview of recent activity on the County Courses. He noted that rounds were up 15% from last year for April and 26.1% year-over-year. He also reported that total revenue for the year so far is \$2,015,952 up 26.5% from last year at this time. Mr. Janoski also reviewed recent turf management activity including the aeration of greens and fairways. He reviewed the upcoming high school championships being held on the County courses.

Vice Chairman Fiore asked about the status of the revised tee-time reservation system, since measures were put in place in 2022 to increase fairness in access to premium times.

Mr. Janoski reported that the system was working well and there have not been recent golfer complaints.

Commissioner Tom Adcock asked if the 30-day advance tee time option was functioning as intended and Mr. Janoski confirmed that it was.

Commissioner Thom Hennessy asked about the aeration process and the steps for watering-in the sand.

Chairman Kevin Mandeville thanked Mr. Janoski and noted that the high numbers of rounds was due primarily to the quality of the County Golf Courses.

PRESENTATION:

Principal Park Planner Paul Gleitz provided an overview of the Municipal Land Preservation Incentive Program. Mr. Gleitz reminded the Board that the new program is a spin-off of the Municipal Open Space Grant Program. The two programs will now separately address the needs of municipalities to fund park improvement projects and land preservation projects, he explained. Mr. Gleitz noted that the program was an outgrowth of the Park System's successful experience with prior Shared Services Agreements with Wall, Aberdeen, and Millstone Townships.

The Board asked Mr. Gleitz to clarify certain details of the program, to which it was resolved:

- Municipalities will be permitted to have one active project at a time.
- If a municipality acquires a conservation easement, they will be required to include a "right of first refusal" option.
- If environmental review of a target parcel reveals contamination issues, the municipality would have the option to suspend the project.
- All Monmouth County municipalities will be formally notified of the new program.
 - A reasonable timeframe for surplus building demolition will be included in the Shared Services Agreement.

The Board authorized Mr. Gleitz to move forward and distribute the application packet to all Monmouth County Municipalities.

At 7:45 PM, Ross F. Licitra, County Commissioner/MCPS Liaison, joined the meeting.
