Director Andrew Spears shared with the Board that there had been a number of recent social media posts from residents objecting to the fees for kayak launching at Swimming River Park. Mr. Spears said that he would review the current fee structure and make a proposal for the Board for adjustment of the season ramp pass fee for non-trailered vessels.

PARKS REPORT:

County Park Superintendent Tom Fobes presented to the Board a review of recent activity in the parks. He presented photos of Park Ranger response to two recent storm events. He also included images of other recent Ranger activity including relocation of the Fisherman's Cove overflow parking lot, preparation for the seasonal openings of Portland Place and Seven Presidents Oceanfront Park, and preparations for the ribbon cutting at Swimming River Park. Mr. Fobes also discussed the installation of a new restroom trailer at the Nomoco Activity Area of Turkey Swamp Park. He thanked the Board for their support and guidance.

County Commissioner Lori Ann Davidson commented that she and her family recently camped at Turkey Swamp Park and enjoyed their stay. She suggested that we note on the web site that certain campsites require additional garden hose to make a connection from the hydrant to the patron's camper.
