Catherine Moraetis, Middletown, addressed the Board regarding her concern that the County's mini golf outings are unfairly taking away tee times from casual golfers on the weekends. Ms. Moraetis maintained that the outings wind up losing money since many of the outing golfers are out-of-County residents who would likely pay more if they played in a typical foursome. Ms. Moraetis asked the Board to reconsider that practice of offering these outings on weekends and holidays. She also asked the Board to consider forming a golf advisory committee, comprised of Monmouth County resident golfers.

Vice Chairman Fiore agreed with Ms. Moraetis and said that outings should not be offered on weekends. He also said that golf staff should make better use of social media to get word out on golf course conditions, especially on days when there are frost delays.

Chairman Kevin Mandeville thanked Ms. Moraetis for bringing the issue to the Commissioners' attention. He directed staff to review the issue with the Board's golf sub-committee and report back to the full Board at one of the regular December meetings.

#### **COUNTY COMMISSIONER'S REPORT:**

County Commissioner Ross F. Licitra was unable to attend the meeting.

## **PRESENTATION:**

Laurie Kelly, Manager of the therapeutic horseback riding program at the Sunnyside Equestrian Center, provided the Board with an update on the program. She said that the program is thriving and enrollment has been steadily increasing. She explained that there are currently five PATH-certified instructors, along with two in training to become certified. She also noted that the program relies heavily on the 100 volunteers who are currently serving. Ms. Kelly noted that there are presently 13 horses in the herd. Ideally, she said, there should be 15-16 horses on site to meet the demand for programs. She gave an overview of Sunnyside programs including: therapeutic riding; traditional youth riding; school groups; and summer camps. Ms. Kelly closed by providing case studies of students who have benefited from the program.

Chairman Mandeville commended Ms. Kelly for the outstanding work that she and her staff do.

## ITEMS FOR BOARD REVIEW:

Chairman Mandeville, regarding item #1, authorizing the purchase of a Bobcat Compact Track Loader, asked if the new equipment would be stored in a building.

Superintendent of Parks Tom Fobes replied that it would be.

Regarding item #4, retaining the services of Lightscapes Studio to offer art programs, Superintendent of Recreation Patti Conroy reported that these programs in 2023 were run above the break-even mark.

Regarding item #6, authorizing change order #1 to Santorini Construction for the Deep Cut Program Cottage Reconstruction, Chairman Mandeville directed staff to include a detailed memo from Epic Management, the construction management firm on the project, for all future change order requests.
