Patrick Trischiita, Holmdel, addressed the Board regarding Holmdel Township's intended preservation of the Horn Antenna Site and Crawford's Hill. He reminded the Board of the historic significance of the site and the local and international support for its preservation. He suggested that the Board consider assisting Holmdel Township with funding for the purchase and ultimate restoration of the site and the development of interpretational exhibits.

Director Andrew Spears explained that County Commissioner Licitra and Parks staff recently met with Holmdel Township officials. During the meeting, Commissioner Licitra suggested to the township that they apply for a Municipal Land Preservation Incentive Grant to offset the purchase price of the site.

ITEMS FOR BOARD REVIEW:

Commissioner Pat Butch asked for additional details on agenda Items 11 and 12, appraisal services for "paper streets" at Charleston Springs Golf Course in Millstone and Shark River Park in Tinton Falls.

Principal Park Planner Paul Gleitz said that these streets were leftover on municipal subdivision plans and were not included in the purchase price of the adjacent park lands. He explained that by assigning a value to the paper streets, an accurate figure could be added to the Park System's official land register.

The Board directed staff to explore other options for assigning values to the paper streets and report back at a future meeting.

Commissioner Mike Harmon asked for additional details on agenda Item 22, recommendation to enter into a lease with Trinity Episcopal Church in Asbury Park for the Park System's afterschool program.

Superintendent of Recreation Patti Conroy explained that the Parks pay \$1,100 per month for use of the building.

Commissioner Harmon suggested that staff contact First Tee staff about the possibility of offering instructional youth golf classes at Trinity Church property and the adjacent park.
