HOMINY HILL GOLF COURSE BUNKER RESTORATION, PHASE 3, Bid # 0046-14 previously advertised by the Monmouth County Board of Recreation Commissioners, 805 Newman Springs Road, Lincroft, New Jersey. This clarification is being issued in response to some questions and inconsistencies that have been identified during the bid process. The content of the bid documents are not being changed or modified.

CLARIFICATIONS

- Proposal Page – Part B: Alternate Bid Items** – last sentence in description reads:
... installation of topsoil, bunker sand and sod as defined by the Detailed Bunker Plan for **Hole #9** labeled Alternate #1.
It should read:
... installation of topsoil, bunker sand and sod as defined by the Detailed Bunker Plan for **Hole #8** labeled Alternate #1.
Hole #9 should read **Hole #8**.
- Proposal Page – Part A: Base Bid-Item #2 Description reads:
“Restore three (3) right fairway bunkers (2,125 SF)”
General Plan reads “Eliminate one (1) and Rebuild two (2) bunkers”
Proposal page is correct, as is Detailed Plans – Hole #2 Base bid.
- To clarify a question brought up at the pre-bid meeting on August 6, 2014, The Contractor is to provide all materials required **OTHER** than additional fill. If needed, the Owner will provide additional fill as per sections **7.05 A, 9.01 B** and **9.01 I**.
