2. Each toilet room shall have a hard wired fire alarm with strobe. System Sensor ADA, or eq. UL and NFPA approved only.
3. No exit signage is required in the toilet rooms.
4. Current MCPS security consultant is Complete Security Systems, 732-780-6787.
5. Existing FACP and electrical panels are located in the basement.
6. Alternate Bid #1- Existing exit sign at rear door to be relocated or reinstalled as necessary.
