Robert Trent Jones designed this championship par 72 course. It has often been rated one of the Top 25 Public Golf Courses by Golf Digest magazine. This course has hosted two USGA championship events: the 1983 Amateur Public Links and the 1995 Women's Amateur Public Links. Course amenities include a golf center with snack bar, driving range, practice putting green, and locker rooms with showers.
