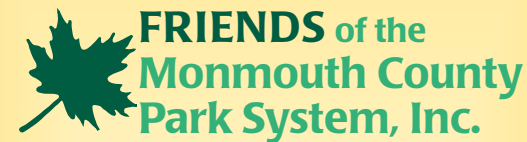

This course has hosted two USGA championship events: the 1983 Amateur Public Links and the 1995 Women's Amateur Public Links. Course amenities include a golf center with snack bar, driving range, practice putting green, and locker rooms with showers.
