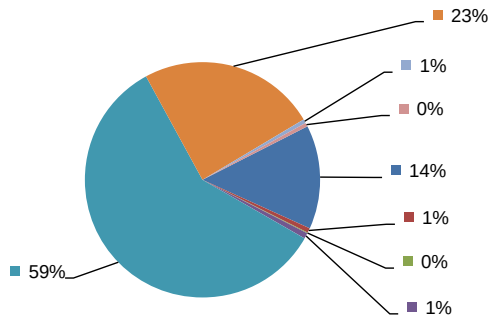
Total Assessed to Equalized Value
