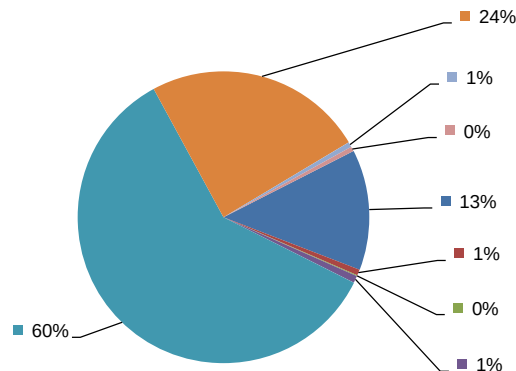
TOTAL ASSESSED-VALUE to EQUALIZED-VALUE
