- 1) Welcome from Joe Barris, Monmouth County Division of Planning.
 - Joe thanked representatives from County municipalities, neighboring counties, State agencies and institutions, and other participants for continuing to support the group

2) Partner Updates

ISO

- Garrett Byma, ISO, discussed elevation certificates and ABFEs. He recommended that everyone subscribe to the CRS newsletter for updates and resources.
- Review of ECs All of last years' re-certifications, which were reviewed using the new EC review software. Towns should have been given results. He noted that there is still a backlog due to technical issues. Garrett asked that if your town is coming up on a cycle visit, to please send him your ECs 1-2 months in advance to allow time for corrections if needed. ECs should be at a 90% correctness rate. Garrett explained the EC sampling process. If a town has less than 70 ECs on file they should send them all to Garrett. If a town has more than 70 ECs they should send Garrett a permit list and he will randomly select 70 ECs for review. If there are errors, all ECs will have to be corrected, not just the sample. Minor corrections in section A and B of the EC Correction Form may be made without a surveyor. For re-certifications, all ECs from the previous year should be submitted. More information and common errors can be found in the newsletter.
- <u>ABFEs</u>— CRS credits for ABFEs will sunset on May 1, 2023. This years' cycle will be the last to
 receive those credits. Some communities could lose 1-2 classes as a result; communities should
 start planning now to make up those points.

NJDEP

- Becky Jones, NJDEP, reminded the group to Save-the-Date for the 2019 NJAFM conference in Atlantic City on October 15-17. She also complemented the tenacity of the Monmouth County CRS user group and asked for feedback on what can be done at the state level to help CRS communities. She encouraged members to email her with any ideas or requests.

Monmouth County Planning

- Joe Barris, Monmouth County Planning, told the group that NJAFM is preparing to offer specialized training for CRS communities this summer. They are asking CRS User Groups for ideas for specialized training during the October conference.
- Joe discussed the Florida AFM conference that he attended in March. FEMA will begin the
 process of moving from a set rate to actuarial risk by 2021. Homes will not have to be in a flood
 hazard area to be risk-assessed. Refer to the Risk Rating 2.0 Overview handout (see CRS

Monmouth County OEM

Mitigation Plan kickoff meeting was held on February 20, 2019. In attendance were Monmouth
County OEM, Planning, and consultants from Michael Baker. He noted that the federal
government is looking to increase pre-disaster mitigation funding from 50 to 300 million dollars.
The next meeting is tentatively scheduled for May 23rd.

Monmouth University

 Dr. Tom Harrington, Monmouth University, informed the group that Monmouth University has taken over the County's tidal gauge data and is also monitoring coastal lakes. Monmouth University is also working with Michael Baker on mitigation strategies to be considered in the Raritan/Sandy Hook Bay Coastal Resilience Planning Study.

 Linda Brennen, Supervising Planner, gave an overview of the major resilience studies that are taking place in CRS communities including the Raritan/Sandy Hook Bay Coastal Resilience Planning Study, the US ACE NJ Back Bay Study, and the NY & NJ Harbor & Tributaries Focus Area Feasibility Study (HATS).(see CRS program webpage).
