NJDEP: New Jersey Coastal Resiliency Plan Overview, Outreach, & Workshop

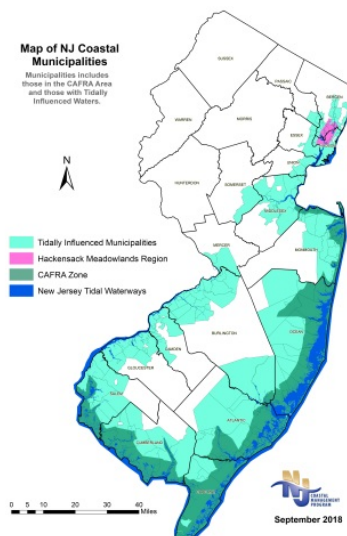
