NOTICE OF PUBLIC HEARING

Notice is hereby given that in accordance with the Federal regulations at 24 CFR, Part 91 and the Monmouth County Citizen Participation Plan, as amended, Monmouth County has prepared a proposed use of funds for the CDBG CV2 Covid-19 allocation from U.S. Department of Housing and Urban Development administered by the New Jersey Department of Community Affairs. The County was allocated \$1,631,935 to undertake activities that prevent, prepare for, and respond to coronavirus. At least 70 percent of the funds available must be used for activities that primarily benefit people of low and moderate income. None of the funds requested will result in the displacement or relocation of people. The County proposes to expend the funds through grants to small businesses and public service providers located in (HUD designated) income eligible areas throughout the County or to Public Service Providers who primarily serve Low/moderate income clientele.
