PUBLIC HEARING AND NOTICE OF PUBLIC COMMENT PERIOD

A Public Hearing regarding Monmouth County's 2021 Annual Action Plan, and The Analysis of Impediments to Fair Housing Choice Report will be held by the Office of Community Development. The purpose of this Public Hearing is to invite public comment and input on the Draft 2021 Annual Action Plan and the Draft Analysis of Impediments to Fair Housing Choice Report. In accordance with the guidelines governing the preparation of the Analysis of Impediments document, the County must hold public forums in order to receive comments from residents about any barriers or discrimination in housing that they have encountered.

As an entitlement community, the Annual Action Plan document is required by HUD and describes the activities proposed by the Monmouth County Consortium to address housing and community development needs of forty-nine (49) municipalities; especially the needs within low-to-moderate income areas. The Monmouth County Annual Action Plan includes projects proposed for funding through the Community Development Block Grant, Home Investment Partnership, and the Emergency Solutions Grant programs. Monmouth County will be submitting this plan in coordination with non-consortium municipalities the Cities of Asbury Park and Long Branch, and the Township of Middletown.

The 30 day public comment period for both documents will start on Monday April 5, 2021 and continue through and include May 5, 2021.
