PUBLIC HEARING AND NOTICE OF PUBLIC COMMENT PERIOD

The Monmouth County Office of Community Development has prepared the FY2024 Annual Action Plan for submission to the U.S. Department of Housing and Urban Development (HUD). The Monmouth County Annual Action Plan includes projects proposed for funding through the Community Development Block Grant, Home Investment Partnership, and the Emergency Solutions Grant programs. Monmouth County will be submitting this plan in coordination with non-consortium municipalities the Cities of Asbury Park and Long Branch, and the Township of Middletown.

A 30-day public comment period for the 2024 Annual Action Plan will start on Monday March 25, 2024, and continue through and include April 24, 2024. Copies of the 2024 Annual Action Plan are available on the Monmouth County Division of Planning, Office of Community Development webpage at [visitmonmouth.com/communitydevelopment](http://visitmonmouth.com/communitydevelopment). Hard copies of the plan are available to review at the Community Development offices.

A hybrid public hearing on the draft FY2024 Annual Action Plan will take place at 2:00 p.m. on Wednesday, April 10, 2024, in the Monmouth County Community Development Conference Room, Hall of Records Annex, One East Main Street, Freehold, NJ, 07728. All citizens are invited to attend. The purpose of the hearing is to obtain the views of citizens, public agencies, and other interested parties on the housing and community development needs as proposed in the FY2024 Annual Action Plan. This facility is handicapped accessible.
