These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the Monmouth County Office of Community Development.

REQUEST FOR RELEASE OF FUNDS

On or about Thursday, September 24, 2026, the Monmouth County Office of Community Development will submit a request to the U. S. Department of Housing and Urban Development for the release of HOME Investment Partnership program funds under Title I of the Housing and Community Development Act of 1974, as amended and National Affordable Housing Act of 1990 to undertake a project known as:

***Habitat for Humanity 2914 Garfield Street Wall, NJ 07719_Census Tract 8086 BG 2
FY 2024 Home Investment Partnership Grant Program (HOME): \$132,181.38***

HOME Investment funds will be for construction of a 1200-square-family home that will consist of three bedrooms and 1.5 bathrooms, full porch and off-street parking available to low to moderate income homebuyers.

FINDING OF NO SIGNIFICANT IMPACT

The Monmouth County Office of Community Development has determined that this project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at Monmouth County Office of Community Development/Division of Planning office and may be examined or copied on weekdays from 8:30 A.M. to 4:30 P.M. A digital copy may be requested.

PUBLIC COMMENTS

Any individual, group, or agency disagreeing with this determination or wishing to comment on the project may submit written comments to the Monmouth County Office of Community Development/Division of Planning, Hall of Records Annex, 2nd Floor, One East Main, Street, Freehold, NJ 07728. All comments received by Wednesday, September 23, 2026, will be considered by the Monmouth County Office of Community Development prior to submitting the request for release of funds. Comments should specify which Notice they are addressing.

RELEASE OF FUNDS

The County of Monmouth certifies to the U. S. Department of Housing and Urban Development that Thomas A. Arnone, in his capacity as The Monmouth County Board of County Commissioners Director consents to accept the jurisdiction of the

Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows the Monmouth County Office of Community Development to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD/State will accept objections to its release of fund and the Monmouth County Community Development's certification for a period of fifteen days (midnight, Monday, October 12, 2026) following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the name of the County of Monmouth; (b) the County of Monmouth has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD/State; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to HUD/State administration office at U.S. Department of Housing and Urban Development, Office of Community Development Planning and Development, Newark CPD Field Office, Region II-New York and New Jersey, Once Newark Center, 1085 Raymond Boulevard, 13th Floor, Newark, NJ 07012 or via email CPD_GeneralCorr-NK@hud.gov. Potential objectors should contact HUD/State to verify the actual last day of the objection period.
