The Monmouth County Fiscal Year 2022 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (FY2022 CAPER) was prepared in accordance with the regulations set forth by the U.S. Department of Housing and Urban Development (HUD). This report must cover the Community Development Block Grant (CDBG) Program, HOME Investment Partnership (HOME) Program, Emergency Solutions Grants (ESG) Program, CARES act, and the affordable housing sections of the County's HUD approved 2020-2024 Consolidated Plan. The FY2022 CAPER report contains the following: a summary of grant resources and accomplishments, status of actions taken during the program year to implement the goals outlined in the Consolidated Plan, and evaluation of the progress made in addressing priority needs and objectives.
