**BOND ORDINANCE AMENDING BOND
ORDINANCE #2021-0005 TO AMEND THE
DESCRIPTION OF CERTAIN IMPROVEMENTS TO
PROVIDE FOR THE BAYSHORE FERRY
TERMINAL BULKHEAD IMPROVEMENTS AND
HALL OF RECORDS IMPROVEMENTS FOR AND
BY THE COUNTY OF MONMOUTH, NEW JERSEY**

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. Bond Ordinance #2021-0005 of the Board of County Commissioners of the County of Monmouth, New Jersey (the "Board") entitled "Bond Ordinance Providing An Appropriation Of \$12,000,000 For Acquisition Of Voting Machines, E-Poll Books And Scanners For And By The County Of Monmouth, New Jersey, And Authorizing The Issuance Of \$11,425,000 Bonds Or Notes Of The County For Financing Part Of The Cost Thereof", finally adopted on August 26, 2021 (the "Ordinance") is hereby incorporated by reference in its entirety.

Section 2: (a) Section 3(a) of the Ordinance is hereby amended by adding at the end of "the acquisition of Voting Machines, E-Poll Books and Scanners" the following: "and Various Improvements - Bayshore Ferry Terminal - Bulkhead Improvements and Various Improvements - Hall of Records Improvements"

(b) Section 6(b) of the Ordinance is hereby amended by deleting the reference of 15 years for the useful life and substituting in lieu therefor 16.65 years.

Section 3. The capital budget of the Board is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolutions in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. All other provisions of the Ordinance shall remain unchanged.

Section 5. This amendatory bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1.
