

## **ARRANGEMENTS FOR ASBESTOS DISPOSAL AT THE MONMOUTH COUNTY RECLAMATION CENTER**

- \* Asbestos is accepted **Monday thru Friday – by appointment only**. Call 732-683-8686 extension 5601 or 5658, 24 – 48 hours before disposal.
- \* A four-part asbestos notification form must be filled out by the homeowner, or contractor and the **white copy must be sent to the NJDEP at least 10 days** before it is brought to the landfill (bottom page of this PDF).
- \* All asbestos must be double bagged in leak tight 6-mil plastic bags and sealed with duct tape, and properly labeled. It cannot be mixed with other wastes.
- \* For smaller quantities, the landfill must be called 24 to 48 hours prior to arriving with the bagged and labeled asbestos.
- \* For truckload and larger quantities (more than five cubic yards or about 25 bags), the landfill must be called at least five days prior to arriving with the bagged and labeled asbestos.
- \* **The hauler must be prepared to manual unload truck or container into the containers provided at the Reclamation Center.**

**We appreciate your cooperation with this new policy for larger loads of asbestos, which is necessary as the County now transfers all asbestos waste to another outside disposal site. This has proven to be less costly than building another special asbestos disposal area on the landfill properties, and allows us to offer you a better price!**

# Please Read This First - BOTH Sides

(REV 1/12) ASBESTOS TRANSPORT AND DISPOSAL REGULATIONS (EXCERPTED FROM N.J.A.C. 7:26-1 et. Seq.)

The following constitutes the most recently promulgated regulations specific to the transport and disposal of asbestos and asbestos containing wastes. Please be advised that other portions of the Solid Waste Regulations may also apply.

## **NJAC 7:26-2.12 Generator requirements for disposal of asbestos containing waste materials**

(a) Generators of asbestos containing waste materials shall comply with the standards for waste disposal at 40 CFR 61.149 and 40 CFR 61.150.

(b, c) Generators of regulated asbestos containing material shall submit a \*written notification of intention to demolish or renovate at least 10 days prior to beginning the demolition / renovation activity.

\*NCR-type [4-part] MCRC specific form letter can be mailed, or picked up at the Monmouth County Reclamation Center Scale Office or the Monmouth County Health Department Offices.

## **29 CFR 1910.1001, AIDD. H**

E. Material containing asbestos that is removed from buildings must be disposed of in leak-tight 6-mil plastic bags. These wastes, which are removed while wet, should be sealed in containers before they dry out to minimize the release of asbestos fibers during handling.

## **MONMOUTH COUNTY RECLAMATION CENTER POLICY**

All asbestos, (friable and non-friable) must be double bagged in leak-tight 6-mil (mil = thickness) plastic bags. Asbestos shingles, (often have sharp edges) and thus may be placed into cardboard boxes or burlap bags prior to being double bagged (to avoid bag breakage). After double bagging the asbestos in the 6-mil bags, each bag must be goose necked, then sealed with duct tape. Upon disposal, it will be customer's responsibility to fix holes in bags with duct tape.

## **40 CFR 61.150**

(a) (iv) Label the wrapped materials using warning labels (if not printed on bag already): Stating:

## **DANGER: ASBESTOS CANCER AND LUNG DISEASE HAZARD**

## **NJAC 7:26-3.5(d) Rules concerning transportation of asbestos and asbestos-containing waste materials:**

- 1 All solid waste vehicles used for the transportation of asbestos and asbestos-containing waste materials shall be of such a design so as to prevent any spillage or leakage or emissions there from.
- 2 No transporter shall transport asbestos and/or asbestos containing waste materials unless such waste is properly packaged in accordance with 40 CFR 61.150 and NJAC 7:26-2.12.
- 3 The asbestos or asbestos-containing waste materials shall be transported in a manner that prevents the rupture of the asbestos containers in loading, transport, and unloading operations.
- 4 Once collected, asbestos and/or asbestos containing waste materials shall be transported directly from the point of generation to the solid waste landfill or transfer station permitted to receive such wastes.
- 5 There shall be no visible air emissions during loading, transporting, or unloading operations.

# Please Read This First - BOTH Sides

## Asbestos cannot be mixed with other wastes & MUST be generated within Monmouth County

For loads in excess of 5 cubic yards (more than 25 bags), Monmouth County Reclamation Center (MCRC) must be called at least 5 days prior to disposal. For smaller loads (25 bags or less) MCRC will only need between 24 and 48 hours prior notice before the asbestos disposal. Call the MCRC scale office at 732-683-8686 ext. 5601 or Monmouth County Solid Waste Enforcement Office ext. 5658 to schedule your appropriate appointment. Asbestos is accepted Monday thru Friday at 10 a.m only.

The hauler must be prepared to manually unload truck or container into the containers provided at the Monmouth County Reclamation Center.

The present disposal rate for "Asbestos Containing Waste" at the Monmouth County Reclamation Center is \$174.10 per ton - pro rated at the rate of \$1.72 per twenty-pound increment. Your hauling and pricing questions can be answered by calling 732-683-8686 ext. 5601.

A simple 4-part asbestos notification form (supplied by MCRC) must be filled out by the homeowner / contractor. The top (white) copy of the form must be sent to NJDEP, at the address on the top of the 4-part notification form. The remaining 3 parts of the form must be submitted to the landfill at the time of disposal for each load. The 4-part asbestos forms can be obtained at the Reclamation Center Scale Office. Care must be taken to estimate the amount of asbestos to be disposed of as accurately as possible, as the Solid Waste Enforcement Team must report discrepancies to the USEPA. A homeowner whom removes and delivers the asbestos to the Reclamation Center must fill in their name as the 'Removal Contractor' and 'Transporter'. If your form is incomplete, you will be directed to the Health Department and will have to return to the end of the line for processing by the scales. The remaining sections of this form must accompany the transporter with the asbestos load to the landfill. After mailing, do not wait for the State to contact you. Call **732-683-8686 (ext. 5601)** for an appointment and job number **24 to 48 hours in advance** of the intended disposal date. Asbestos is only accepted Monday thru Friday at the MCRC.
